## Consent Agenda

Ms. Holmes presented the Executive Director Report. Ms. Holmes informed the board that she was notified by Brevard Public Schools that the funding for Head Start was being reduced by \$233,000 for next fiscal year due to the sequestration and the C.A.R.E.S. Head Start contract in the amount of \$250,000 would be eliminated. Ms. Holmes discussed with BPS the possibility of C.A.R.E.S. retaining one CARE Coordinator position to work with Head Start families determined to be at high risk.

Ms. Holmes announced that C.A.R.E.S. will remain at its current location. Ms. Holmes asked the building owner, Ms. Victoria Mitchell, if she would consider a rent reduction. Ms. Mitchell indicated that she'll consider the request and evaluate the options.

Ms. Holmes reported that C.A.R.E.S. has entered into a consultant agreement with Mattek, a Medicaid Consultant agency to assist C.A.R.E.S. in becoming approved as a Targeted Case Management provider.

Ms. Holmes informed the Board that she has an upcoming meeting with Javier Molinares, publisher of the Hispanic newspaper Al Dia to discuss partnering with him to help connect the Hispanic population with available community resources.

Ms. Holmes presented the Monthly Board Data for February 2013.

Ms. Hensler presented C.A.R.E.S. financial statements for February 2013.

Ms. Hensler presented Head Start financial statements for February 2013.

Old Business

Ms. Goodwin informed the board that she will be ordering business cards for all board members. She asked if they would prefer the title on the member cards to read "Board Member" or "Community Member"? After discussion the board agreed that the title for the board members should read "Board Member". Ms. Goodwin will move forward with ordering the business cards.
