## Consent Agenda

Ms. Holmes presented the Executive Director Report. Ms. Holmes announced that C.A.R.E.S. has partnered with Our Lady of Lords Catholic Church to train clergy volunteers in accessing community resources. Ms. Holmes also announced that C.A.R.E.S. has entered the second phase as a finalist for the Youth Thrive Initiative grant.

Ms. Holmes informed the board that she has been participating in a statewide work group that is advocating for Wraparound to become a Medicaid reimbursable activity. The Homeless Grant began on July 1. The new contract for Head Start Care Coordinator was approved by Brevard Public Schools on June 27 in the amount of \$64,800.

Ms. Holmes reported that C.A.R.E.S. partnered with Brevard Family Partnership to submit an application for the Juvenile Justice and Child Welfare Multi-System Integration Certificate Program at Georgetown University. C.A.R.E.S. also entered into a partnership with Crosswinds Youth Services for Redirections funding for several counties in the central Florida area.

Ms. Holmes presented the Monthly Board Data for May and June 2013.

Mr. Martinez left the meeting.

Ms. Hensler presented C.A.R.E.S. financial statements for May 2013.

Ms. Hensler presented Head Start financial statements for May 2013.

## Old Business

Ms. Hernandez reported that the PR Task Force has been strategizing different ways to fund raise and raise awareness. Currently the PR Task Force is reaching out to several restaurants regarding participating in a Dine Out event. Ms. Hernandez announced that a donation link has been added to C.A.R.E.S. website for monetary donations.
